1. The instant society, if found involved or indulged in activities subversive to the society or subversive to the security of the UT of J&K and Country or maintenance of law and order, the registration of society shall be deemed to be canceled.
2. The Society registration shall be liable to cancellation, in case, it has been obtained by misrepresentation/fraudulently fake documentation. This shall also attract punitive action under relevant provisions of Law.
3. This certificate of registration does not construe any statutory permission/license to the society to undertake Aims/Objectives as specified in Bye-Laws /MoA/Constitution filed with this office, which, however, shall be subject to the production of NOC(s)/License(s), required if any, under any other law/statute of the Government (Centre/UT)
4. The document certifies registration under the Society Registration Act 1860 only. However, any Government Department/any other association/person(s), etc. may make necessary verification (on their own) regarding the society's conduct, assets & liabilities, etc. before entering into any contract/ assignment with the instant society.
5. The society shall not be entitled to use it's translated/ abbreviated/ acronym name & shall use the registered name only clearly indicating that it is governed by a private body/society and not by the Government.
6. Further, the society shall not be used for any commercial, trade, business purpose, profession, or certification/affiliation/recognition to other organizations.
7. Under no circumstances shall the Society change its registered name, members, address of the society, constitution/bylaws, etc. except with the prior approval/ permission of the Registrar of Societies, Jammu.
8. **The instant society shall submit a copy of Bank Account / FCRA Details (if applicable), and PAN Card details in the O/o Registrar of Societies, Jammu within 45 days from the issuance of the Registration Certificate failing which action as warranted under Law shall be initiated against the society.**
